**EYES:** FLOOD WITH LUKEWARM (NOT HOT) WATER POURED FROM A LARGE GLASS 2 OR 3 INCHES FROM EYES. REMOVE CONTACTS. HAVE PATIENT BLINK AS MUCH AS POSSIBLE WHILE FLOODING THE EYES. CONTINUE FOR AT LEAST 15 MINUTES.

**SKIN:** REMOVE CONTAMINATED CLOTHES, FLOOD WITH WATER FOR 15 MINUTES. **INHALATION:** MOVE VICTIM TO FRESH AIR. GIVE ARTIFICIAL RESPIRATION IF PATIENT IS NOT BREATHING.
