Steps To Be Taken In Case Material Is Released Or Spilled: Caution. Floors may become slippery. Isolate spill or leak area immediately. Keep unauthorized personnel away. Stay upwind. Keep out of low areas. Ventilate closed spaces before entering. Wear appropriate personal protective equipment during clean-up. **Small Spills:** Absorb with earth, sand or other non-combustible materials. Transfer to containers for later disposal. Use clean non-sparking tools to collect absorbed material. **Large Spills:** Dike ahead of liquid spill for later disposal. Keep spill out of sewers and open bodies of water.
