## Section 2. Hazards identification

**Physical state** : Liquid. [Liquid.]  
**Emergency overview** : DANGER !

CAUSES DIGESTIVE TRACT, EYE AND SKIN BURNS.  
HARMFUL IF ABSORBED THROUGH SKIN OR IF SWALLOWED.  
CAUSES RESPIRATORY TRACT IRRITATION.

## Section 4. First aid measures

**Eye contact** : In case of contact, immediately flush eyes with cool running water. Remove contact lenses and continue flushing with plenty of water for at least 15 minutes. Get medical attention immediately.

**Skin contact** : In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Get medical attention immediately. Wash clothing before reuse. Clean shoes thoroughly before reuse.

**Inhalation** : If inhaled, remove to fresh air. If exposed person is not breathing, give artificial respiration or oxygen applied by trained personnel. Get medical attention immediately.

**Ingestion** : If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Do not induce vomiting. Never give anything by mouth to an unconscious person. Get medical attention immediately.

## Section 5. Fire-fighting measures

**Flash point** : 58.3333 °C (Closed cup)

**Hazardous thermal decomposition products** : Decomposition products may include the following materials:

**Fire-fighting media and instructions** : Use dry chemical, CO<sub>2</sub>, water spray (fog) or foam.

Use water spray to keep fire-exposed containers cool. Dike area of fire to prevent runoff.

Combustible liquid. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion.

**Special protective equipment for fire-fighters** : Fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode.

## Section 6. Accidental release measures

**Personal precautions** : Immediately contact emergency personnel. Stop leak if without risk. Use suitable protective equipment. Keep unnecessary personnel away. Do not touch or walk through spilled material.

**Environmental precautions** : Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).

**Methods for cleaning up** : If emergency personnel are unavailable, contain spilled material. For small spills, add absorbent (soil may be used in the absence of other suitable materials), scoop up material and place in a sealable, liquid-proof container for disposal. For small spills, add absorbent (soil may be used in the absence of other suitable materials) and use a non-sparking or explosion-proof means to transfer material to a sealable, appropriate container for disposal. For large spills, dike spilled material or otherwise contain it to ensure runoff does not reach a waterway. Place spilled material in an appropriate container for disposal.

## Section 7. Handling and storage

**Handling** : Do not ingest. Do not get in eyes, on skin, or on clothing. Do not breathe vapor or spray. Keep away from heat, sparks and flame. To avoid fire, eliminate ignition sources. Keep container closed. Use only with adequate ventilation. Wash thoroughly after handling.

**Storage** : Keep out of reach of children. Store in a segregated and approved area. Keep container in a cool, well-ventilated area. Keep container tightly closed and sealed until ready for use. Avoid all possible sources of ignition (spark or flame).  
Do not store above the following temperature: 50°C

## Section 8. Exposure controls/personal protection

**Engineering measures** : Use only with adequate ventilation. If user operations generate dust, fumes, gas, vapor or mist, use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits. The engineering controls also need to keep gas, vapor or dust concentrations below any lower explosive limits. Provide suitable facilities for quick drenching or flushing of the eyes and body in case of contact or splash hazard.

### Personal protection :

**Eyes** : Use chemical splash goggles. For continued or severe exposure wear a face shield over the goggles.

**Hands** : Use chemical-resistant, impervious gloves.

**Skin** : Wear suitable protective clothing.

**Respiratory** : Wear appropriate respirator when ventilation is inadequate and occupational exposure limits are exceeded.
