4. First Aid Measures

5. Fire Fighting Measures

Flammable properties

Heat may cause the containers to explode. Vapor or gas may spread to distant ignition sources and flash back. Runoff to sewer may cause fire or explosion hazard.

Protection of firefighters

Protective equipment and precautions for firefighters Water fog. Foam. Dry chemical powder. Carbon dioxide (CO2).

In case of fire and/or explosion do not breathe fumes. Containers should be cooled with water to prevent vapor pressure build up. Move containers from fire area if you can do so without risk. Cool containers exposed to flames with water until well after the fire is out. For massive fire in cargo area, use unmanned hose holder or monitor nozzles, if possible. If not, withdraw and let fire burn out.

6. Accidental Release Measures

Methods for containment

Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable. Stop the flow of material, if this is without risk.

Methods for cleaning up

Should not be released into the environment. Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

7. Handling and Storage

Handling

Pressurized container: Do not pierce or burn, even after use. Do not smoke while using or until sprayed surface is thoroughly dry. Do not use if spray button is missing or defective. Do not re-use empty containers. Avoid contact with skin. Avoid contact with eyes. Avoid prolonged exposure.

Storage
