4. First Aid Measures

First aid procedures

Eye contact Immediately flush eyes with plenty of water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention if irritation develops and persists.

Pressurized container: Do not pierce or burn, even after use. Do not smoke while using or until sprayed surface is thoroughly dry. Use only in area provided with appropriate exhaust ventilation. Do not use if spray button is missing or defective. Do not re-use empty containers. Avoid contact with skin. Avoid prolonged exposure.

Storage

Contents under pressure. Do not puncture, incinerate or crush. The pressure in sealed containers can increase under the influence of heat. Avoid exposure to long periods of sunlight. Store in cool place. Keep away from food, drink and animal feedingstuffs. Level 3 Aerosol.
