## Section 3. Hazards identification

## Section 4. First-aid measures

Eye contact : In case of contact, immediately flush eyes with cool running water. Remove contact lenses and continue flushing with plenty of water for at least 15 minutes. Get medical attention immediately.

Skin contact : In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Get medical attention immediately. Wash clothing before reuse. Clean shoes thoroughly before reuse.

Inhalation : If inhaled, remove to fresh air. If exposed person is not breathing, give artificial respiration or oxygen applied by trained personnel. Get medical attention if irritation persists.

Ingestion : If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. Do not induce vomiting. Never give anything by mouth to an unconscious person. Get medical attention immediately.

## Section 6. Accidental release measures

<b>Personal precautions</b>	: Immediately contact emergency personnel. Stop leak if without risk. Use suitable protective equipment. Keep unnecessary personnel away. Do not touch or walk through spilt material.
<b>Environmental precautions</b>	: Avoid dispersal of spilt material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).
<b>Methods for cleaning up</b>	: If emergency personnel are unavailable, contain spilt material. For small spills, add absorbent (soil may be used in the absence of other suitable materials), scoop up material and place in a sealable, liquid-proof container for disposal. For large spills, dyke spilt material or otherwise contain it to ensure runoff does not reach a waterway. Place spilt material in an appropriate container for disposal.

## Section 7. Handling and storage

<b>Handling</b>	: Do not ingest. Do not get in eyes, on skin, or on clothing. Avoid breathing vapours, spray or mists. Keep container closed. Use only with adequate ventilation. Wash thoroughly after handling. Do not mix with bleach or other chlorinated products – will cause chlorine gas.
<b>Storage</b>	: Keep out of reach of children. Keep container in a cool, well-ventilated area. Keep container tightly closed. Do not store below the following temperature: 0°C
