INHALATION: GET PERSON TO FRESH AIR. IF UNCONSCIOUS CALL PHYSICIAN.

SECTION 7 - PRECAUTIONS FOR SAFE HANDLING AND USE.

STEPS TO BE TAKEN IN CASE MATERIAL IS RELEASED OR SPILLED:

SOAK UP WITH INERT, ABSORBENT MATERIAL. SCOOP UP AND PLACE IN A PROPER WASTE DISPOSAL CONTAINER.

WASTE DISPOSAL METHOD:

DISPOSE OF IN ACCORDANCE WITH STATE AND LOCAL REGULATIONS. PRECAUTIONS TO BE TAKEN IN HANDLING AND STORING: STORE IN COOL, DRY PLACE. DO NOT FREEZE OR HEAT ABOVE 110 F.

OTHER PRECATIONS: KEEP OUT OF REACH OF CHILDREN. FOLLOW DIRECTIONS ON THE CONTAINER FOR PROPER USE OF THIS PRODUCT.
