III. HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW:

CORROSIVE - Contains alkalis and chlorinated chemicals. Causes severe burn to skin and eyes. May be fatal if swallowed. Do not contact eyes, skin or clothing. Wear goggles, face shield, rubber gloves, and protective clothing and boots when handling products. Avoid breathing dust or spray mist. Use respiratory protection for any breathing difficulty. TOXIC CHLORINE VAPORS may be released by fire or mixing with acids or ammonia. Contain spill and runoff, which may cause environmental damage.
