2. HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

DANGER. CORROSIVE. Causes skin and eye burns. HARMFUL OR FATAL IF SWALLOWED. May cause respiratory tract irritation . COMBUSTIBLE LIQUID AND VAPOR.

Principle routes of exposure:

4. FIRST AID MEASURES

Eye contact:

Immediately flush eyes with running water for at least 15 minutes, keeping eyelids open. Get medical attention immediately.

Skin contact:

Flush immediately with plenty of water for at least 15 minutes. Get medical attention immediately.

Inhalation:

If breathing is affected, remove to fresh air. Get medical attention immediately.

Ingestion:

Do not induce vomiting. Immediately drink one cupful of water or milk. Never give anything by mouth to an unconscious person. Get medical attention immediately.

Aggravated Medical Conditions:

Individuals with chronic respiratory disorders such as asthma, chronic bronchitis, emphysema, etc., may be more susceptible to irritating effects .

5. FIRE-FIGHTING MEASURES

Suitable extinguishing media:

Use dry chemical, CO2, water spray or "alcohol" foam.

Specific hazards:

Keep product and empty container away from heat and sources of ignition.

Unusual hazards:

Corrosive material (See sections 8 and 10).

Specific methods: No special methods required

Special protective equipment for firefighters: As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full protective gear

6. ACCIDENTAL RELEASE MEASURES

Personal precautions: Put on appropriate personal protective equipment (see Section 8.). Remove all sources of ignition.
Environmental precautions and clean-up methods: Clean-up methods - large spillage. Prevent product from entering drains. Absorb spill with inert material (e.g. dry sand or earth), then place in a chemical waste container. Sweep up and shovel into suitable containers for disposal. Use a water rinse for final clean-up .

7. HANDLING AND STORAGE

Handling:

Keep away from open flames, hot surfaces and sources of ignition. Avoid contact with skin, eyes and clothing. Do not taste or swallow. Avoid breathing vapors or mists. Use only with adequate ventilation. Remove and wash contaminated clothing before re-use. Wash thoroughly after handling. Product residue may remain on/in empty containers. All precautions for handling the product must be used in handling the empty container and residue.

Storage:

Keep tightly closed in a dry, cool and well-ventilated place. Keep away from heat. Keep out of the reach of children.
