### 2. HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

## **4. FIRST AID MEASURES**

Hold eye open and rinse slowly and gently with water for 15-20 minutes. Eye contact:

Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Call medical

attendant, medical doctor, or poison control center.

Take off contaminated clothing . Rinse skin immediately with plenty of water for 15-20 minutes . Call Skin contact:

medical attendant, medical doctor, or poison control center . Remove and wash contaminated clothing

and footwear before re-use.

Inhalation: If breathing is affected, remove to fresh air. If person is not breathing, call 911 or an ambulance and then

give artificial respiration, preferably by mouth to mouth, if possible. Call medical attendant, medical doctor,

or poison control center

Ingestion: Call medical attendant, doctor, or poison control center immediately. Have person sip a glass of water if

able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor . Never

give anything by mouth to an unconscious person.

### 5. FIRE-FIGHTING MEASURES

Suitable extinguishing media:

Specific hazards:

Flood with water. . Do not use dry chemical extinguishing agents. Violent reaction may result Oxidizer . Decomposition releases oxygen, which may intensify fire . In large fires fueled by other materials, this product may smolder for prolonged periods emitting a dense, black smoke . Any spilled material should be considered contaminated. Neutralize to a non-oxidizing material for safe disposal Fires fueled by other materials may release hydrogen bromide, bromine, hydrogen chloride, or chlorine.

Oxidizer . Decomposition releases oxygen, which may intensify fire .

**Unusual hazards:** Specific methods:

In case of fire or smoke, call the fire department . Do not attempt to extinguish the fire without a selfcontained breathing apparatus (SCBA). Do not let the fire burn. Flood with copious amounts of water. DO NOT use ABC or other dry chemical extinguishers since there is potential for violent reaction .

#### 6. ACCIDENTAL RELEASE MEASURES

Personal precautions: **Environmental precautions** and clean-up methods:

Put on appropriate personal protective equipment (see Section 8.).

Use appropriate containment to avoid environmental contamination. Water runoff can cause environmental damage. Prevent product from entering drains. Soak up with inert absorbent material. Using clean equipment, sweep and scoop all spilled material, contaminated soil, and other spilled material and place into clean, drv. plastic containers for disposal.

#### 7. HANDLING AND STORAGE

#### Handling:

OXIDIZER . CONTACT WITH OTHER MATERIAL MAY CAUSE FIRE . Do not mix with any other product or chemical . Mix only with water . Use clean, dry utensils . Do not add this product to any dispensing device containing remnants of any other products. Such use may cause a violent reaction leading to fire or explosion . Contamination with organic matter or other chemicals will start a chemical reaction and generate heat, hazardous gas, possible fire and explosion . In case of contamination do not reseal container. If possible, isolate container in open air or well ventilated area. Flood area with large volumes of water .

#### Storage:

Keep this product dry in original tightly closed container when not in use . Store in a cool, dry, well ventilated area away from heat or open flame . In case of decomposition, isolate container if possible and flood area with large amounts of water to dissolve all material before discarding this container. Do not contaminate food or feed by storage or disposal.
