III. HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW:

CORROSIVE - Contains alkalis and chlorinated chemicals. Causes severe burn to skin and eyes. May be fatal if swallowed. Do not contact eyes, skin or clothing.
