2. HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW

DANGER. CORROSIVE. CAUSES EYE AND SKIN BURNS. HARMFUL OR FATAL IF SWALLOWED. NEVER USE OR MIX WITH ACIDS, AMMONIA OR ANY OTHER CHEMICAL. Can react to release chlorine gas.

Principle routes of exposure: Skin contact. Eye contact. Inhalation. Ingestion.

Skin contact: Corrosive. May cause permanent damage.

Eye contact: Corrosive. Causes permanent eye damage, including blindness.

Inhalation: May cause irritation and corrosive effects to nose, throat and respiratory tract.

Ingestion: May cause burns to mouth, throat and stomach .

4. FIRST AID MEASURES

Eye contact: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Get medical attention immediately.

Skin contact: Take off contaminated clothing . Flush immediately with plenty of water for at least 15 minutes. Get medical attention immediately.

Inhalation: If breathing is affected, remove to fresh air. If person is not breathing, call 911 or an ambulance and then give artificial respiration, preferably by mouth to mouth, if possible. Get medical attention immediately.

Ingestion: Call medical attendant, doctor, or poison control center immediately. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor .

Notes to physician: Probable mucosal damage may contraindicate the use of gastric lavage .

Aggravated Medical Conditions: Individuals with chronic respiratory disorders such as asthma, chronic bronchitis, emphysema, etc., may be more susceptible to irritating effects .

5. FIRE-FIGHTING MEASURES

Suitable extinguishing media: The product is not flammable. Dry chemical, water spray, foam, carbon dioxide.

Specific hazards: None known.

Unusual hazards: Corrosive material (See sections 8 and 10).
Specific methods: No special methods required

Special protective equipment for firefighters: As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full protective gear

6. ACCIDENTAL RELEASE MEASURES

Personal precautions: Put on appropriate personal protective equipment (see Section 8.).
Environmental precautions and clean-up methods: Absorb spill with inert material (e.g. dry sand or earth), then place in a chemical waste container. Use a water rinse for final clean-up.

7. HANDLING AND STORAGE

Handling:

Avoid contact with skin, eyes and clothing. Wash thoroughly after handling. Remove and wash contaminated clothing and footwear before re-use. Do not taste or swallow. Avoid breathing vapors or mists. Product residue may remain on/in empty containers. All precautions for handling the product must be used in handling the empty container and residue. FOR COMMERCIAL AND INDUSTRIAL USE ONLY

Storage:

Keep tightly closed in a dry, cool and well-ventilated place. Protect from freezing . Keep out of the reach of children.
