Conditions Aggravated by Use: Preexisting respiratory; skin and eye conditions.

Emergency & First Aid Procedures:

Eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses; if present; after the first 5 minutes; then continue rinsing eye. Call a poison control center or doctor for treatment advice.

Skin: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

Ingestion: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person. Note
 to Physician: Probable mucosal damage may contraindicate the use of gastric lavage.

Inhalation: Move person to fresh air. If person is not breathing; call 911 or an ambulance; then give artificial respiration; preferably mouth to mouth; if possible. Call a poison control center or doctor for further treatment advice.
