Health Hazards: May cause eye and skin irritation, may cause stomach distress.

Signs/systems of over exposure: Prolonged skin contact may cause mild redness and swelling. Contact with eyes may cause irritation, experienced as discomfort or pain, excessive blinking and tear production, with marked excess redness and swelling. Corneal injury may occur. This product can be absorbed through the skin. Ingestion may cause gastrointestinal irritation with nausea, vomiting, and diarrhea.

Medical conditions aggravated by exposure: Skin contact may aggravate an existing skin condition.

4. FIRST AID MEASURES

EYE CONTACT: Immediately rinse eyes with plenty of water, occasionally lifting upper and lower lids, until no evidence of product remains. Obtain medical attention if irritation persists.

11. TOXICOLOGY INFORMATION
