5.2. Special hazards arising from the substance or mixture

HAZARDS CAUSED BY EXPOSURE IN THE EVENT OF FIRE

6. Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

Eliminate sources of ignition (cigarettes, flames, sparks, etc.) from the area in which the leak occurred. If there are no contraindications, spray powder with water to prevent the formation of dust. Use breathing equipment if powders are released into the air. Block the leakage if there is not hazard. Do not handle damaged containers or leaked product before donning appropriate protective gear. 8.2. Exposure controls
