## Section 4: FIRST AID MEASURES

- Eye Contact:** In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. If easy to do, remove contact lenses, if worn. Neutralize with 3% boric acid solution, dilute vinegar solution or like dilute mild acid solution. Get medical attention immediately.
- Skin Contact:** In case of contact, immediately flush skin with plenty of water. If necessary, neutralize with 3% boric acid solution, dilute vinegar solution or like dilute mild acid solution. Remove contaminated clothing and shoes. Wash clothing before reuse. Call a physician if irritation develops and persists.
- Inhalation:** If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen.
- Ingestion:** If swallowed, do NOT induce vomiting unless directed to do so by medical personnel. Only if directed by medical personnel, neutralize with 3% boric acid solution, dilute vinegar solution or like dilute mild acid solution. Never give anything by mouth to an unconscious person.
- General Advice:** In case of accident or if you feel unwell, seek medical advice immediately (show the label or MSDS where possible). Keep 3% boric acid solution, dilute vinegar solution or like dilute mild acid solution on hand if neutralization is required.
