### **4. First aid measures**

<b>Eye contact:</b>	Immediately flush with plenty of water. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. Immediately call a POISON CENTER or doctor/physician
<b>Skin contact:</b>	If on Skin (or hair): Remove/Take off immediately all contaminated clothing. Rinse skin with water/shower. Wash contaminated clothing before reuse. Seek medical attention.
<b>Inhalation:</b>	Remove victim to fresh air and keep at rest in a position comfortable for breathing. Immediately call a POISON CENTER or doctor/physician.

### Methods for cleanup and containment of material

**Methods of containment** Prevent further leakage or spillage if safe to do so

**Large spill:** Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Cover the plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers. Following product recovery, flush area with water.

**Small spill:** Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

## 7. Handling and storage

**Handling:** Handle in accordance with good industrial hygiene and safety practice. Use personal protection recommended in Section 8. Avoid contact with skin, eyes or clothing. Wash face, hands, and any exposed skin thoroughly after handling. Do not eat, drink or smoke when using this product. Do not taste or swallow. Use only outdoors or in a well-ventilated area. Avoid prolonged exposure. Do not breathe dust/fume/gas/mist/vapors/spray. Observe good industrial hygiene practices.

**Storage** Keep container tightly closed and store in a cool, dry and well-ventilated place. Store locked up.

### **Appropriate Engineering Controls.**
