**Signal Word.** Danger

**Hazard Statement.** Causes eye and skin burns. Causes respiratory tract irritation. Harmful if swallowed.

**Precautionary Statements.** Wear protective gloves, splash goggles, face shield, full suit, vapor respirator and boots. Do not breathe mist /vapors /spray. Wash thoroughly after handling.

### Acute Effects

**Eyes.** Corrosive to eyes. Causes burns. Inflammation of the eye is characterized by redness, watering and itching.

**Skin.** Corrosive to skin. Causes burns. Skin inflammation is characterized by itching, scaling, or reddening.

**Inhalation.** May give off gas, vapor or dust that is very irritating or corrosive to the respiratory system. Exposure can cause coughing, chest pains and difficulty in breathing.

**Ingestion.** Harmful if swallowed. May cause burns to mouth, throat and stomach. Ingestion may cause erosion of mucous membranes and perforation of the esophagus of stomach.

## 4. FIRST AID MEASURES

## 5. FIRE FIGHTING MEASURES

**Specific Protective Equipment for Fire-Fighters.** Fire-Fighters should wear appropriate protective equipment and self contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode.

## 6. ACCIDENTAL RELEASE MEASURES

**Spill Clean Up.** Put on appropriate personal protective equipment (see section 8). Stop leak if without risk. Move Containers from spill area. Dilute with water and mop up if water-soluble or absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

## 7. HANDLING AND STORAGE

**Handling.** Put on appropriate personal protective equipment (see Section 8). Do not get in eyes or on skin or clothing. Do not breathe vapor or mist. Do not ingest. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Do not reuse container. Wash thoroughly after handling.

**Storage.** Store between the following temperatures: 4.44 to 48.9°C (40 to 120°F). Store in accordance with local regulations. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see section 10) and food and drink. Separate from acids. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers. Use appropriate containment to avoid environmental contamination. Do not store in unlabeled containers.
