4. FIRST AID MEASURES

-Inhalation: Remove victim to fresh air and keep at rest in a position comfortable for breathing. IMMEDIATELY CALL A POISON CENTER OR PHYSICIAN.

5. FIRE-FIGHTING MEASURES
