4. FIRST AID MEASURES

Eye contact: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if

present, after the first 5 minutes, then continue rinsing eyes. Get medical attention immediately. Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Get

medical attention immediately.

Inhalation: If breathing is affected, remove to fresh air. If person is not breathing, call 911 or an ambulance and
